Arellano Landscaping was selected from the three presented bids. Motioned by Karen, seconded by Mike, passed unanimously.

Michael Luton stated the CDD has agreed to partner with the Association in sharing 50% of Sidewalk repair project expenses.

## E. Roof Pressure Cleaning Proposals

Affordable Pressure Cleaning was selected from three bids received to clean Clubhouse, Guardhouse, and bus stop roofs along with four monument signs at the entrance of community. Approved by Mike , seconded by Karen , passed unanimously

#### F. Zoom Platform update

Property Manager announced Zoom account has been purchased per annual subscription and will be used for Board Meetings going forward.

#### A. Playground/ Exterior Amenities

Karen motioned to create an Recreation Committee to research and formulate a plan to renovate or improve outdoor activity areas. seconded by Sandra Reed, all were in favor, none opposed.

Karen appointed Sandra as Committee Chair who was approved unanimously upon her acceptance.

### B. Clubhouse Roof Repair

Request for proposals was motioned by Sandra, seconded by Mike passed unanimously.

#### C. Invest Reserve Funds

Motioned by Sandra to invest portion of the reserve funds for the highest investment yields, seconded by Karen , Passed unanimously.

#### D. Town Hall/Liaison Committee Update

#### E. Clubhouse Parking Passes

A motion to re-instate original Clubhouse parking pass rules so that Security Personnel are allowed to issue passes on weekends and holidays for a maximum 48 hours at a time was



introduced. by Karen, seconded by Mike, the motion passed unanimously. The management office will be the main issuer under other circumstances.
